Draft Minutes of Winterborne St Martin Parish Council

Democratic Period:

A representative from Wessex Internet attended the meeting to provide information regarding a residents' meeting to be held on 1 November at the Village Hall to present their upcoming works in the Parish and advised the following.

- The government has now stopped providers having the monopoly
- BT are phasing out copper network
- Full fibre broadband will eventually be everywhere
- Door to door visits will be carried out by the team in the village
- Register at Wessex Internet online for more information
- Discounted service to community areas such as Church/Village Hall
- Connecting to properties is mainly carried out by a moleing process but in built up areas this tends to be provided by overhead or underground ducting.

A parishioner present asked how much the Parish Council knew about these works and Cllr Nuttall advised very little until now.

Cllr Marsh asked why this is so different to what some residents already have. The representative advised that this next rollout is ultra fibre which provides very much faster speeds for residents.

Cllr Nuttall thanked the representative for attending the meeting.

A parishioner expressed concern with Green Martinstown wanting to know why they are involved in deciding what happens with development on land within the parish.

The parishioner feels this group should be managed by the Parish Council.

Cllrs Marsh & Nuttall sympathised with the concerns being raised but advised that the agreement is between Dorset Council and the group of volunteers, it isn't anything to do with the Parish Council.

It was asked what happens if the group folds and Cllr Walker advised it would fall back to Dorset Council.

The parishioner is concerned that an unelected body manages land in the Parish.

Cllr Walker advised that the group have held meetings where they explain what their intentions are.

a) Dorset Local Plan – discussion to include Cllr Pembertons briefing note

Cllr Nuttall advised that an extra-ordinary meeting was going to be held to give this item more time and to allow for parishioners to be given the opportunity to comment.

Parishioners present at the meeting expressed their concern that this wasn't being discussed as per the agenda item.

A discussion followed with each of the Cllrs giving their initial views which included the following.

- Strong support of having improved infrastructure ahead of any further development being completed
- Guaranteed local affordable and low-cost housing is a must

- Sewage issues need to be dealt with, this is a matter for Wessex Water
- Transport systems need to be adequate

Parishioners present gave the following comments.

- Village needs new housing & affordable/housing association
- Part of the village identified in the plan is appropriate for development
- Infrastructure is the biggest problem
- Housing would be good if more affordable
- Concerns with road network getting in and out of village with more development could become increasingly busier with other traffic using the network
- Sewers need sorting out
- b) Invite received to attend meeting at Rainbarrow Farm to discuss recent planning approvals

Cllr Nuttall informed the meeting that this invite has been received, and he will attend. Cllrs Marsh & Eversden requested to attend also.

a) SID licence concerns received from Dorset Council – Cllr Walker to update

Cllr Walker informed the meeting that solar panels can be placed on the post which would remove the requirement for charging and reduce the risk of the SID not working consistently.

The Clerk advised that the licence to operate the SID would be revoked by Dorset Council if the SID was not operated properly including moving it from one side of the road to the other. The northbound post is so overgrown now that it is impossible for the volunteer to access the post.

A parishioner advised the council that the volunteer who manages the SID can also download data and send to the parish council which shows the speed of the vehicles and volumes. This information used to regularly be submitted to the council, but previous Chairs & Cllrs decided they didn't require the information. Cllr Nuttall suggested this is resumed as it would be useful information to have.

Action: Cllr Walker to bring motion to next meeting regarding the solar panels and maintenance of vegetation. Clerk to advise Dorset Council that the licence needs to remain.
